**156/08 TO RECEIVE APOLOGIES FOR ABSENCE**

Apologies for absence were received from Cllr Stephenson due to illness and Cllr Ward due to having to attend an Isle of Wight Council meeting.

**157/08 TO APPROVE AND SIGN THE MINUTES OF THE TOWN COUNCIL MEETING HELD  
ON 10<sup>TH</sup> JANUARY 08**

Prior to the approval of the minutes the following points were raised by a Councillor who thought the following comments should be in the minutes.

- a. A question was raised regarding the circulation of a list of correspondence with the agenda. The Council had not passed a resolution on this matter so it was not recorded.
- b. A question had been raised at the previous Council Meeting why there were no detailed budget papers circulated. The Clerk responded that she had already said at the previous meeting there were no detailed papers to circulate.

It was agreed that minute **154/08** should be amended to read:- That the date of the Town Council Meeting to include the budget to be held on the 23rd February 08 was noted.

**RESOLVED:-**

THAT with the alteration to minute 154/08 the minutes of the meeting held on the 10<sup>th</sup> January 2008 were approved.

**158/08 TO MAKE DECLARATIONS OF INTEREST**

Cllr Blezzard declared a personal interest in all items as a member of the Isle of Wight Council Scrutiny Committee.

**159/08 TO APPROVE THE BUDGET FOR 2008/09**

The Clerk presented a proposed budget to the Council together with the Risk Assessment she had taken into account when setting the proposed 2008/09 precept of £98000. She reported the cost to the ratepayers of Sandown based on the number of Band D properties in Sandown of 2876.50 (which were figures given by the Isle of Wight Council on Monday 21<sup>st</sup> January 08) would be £34.07 per year in comparison to a budget set last year of £32.90 per Band D properties. It would give an increase of 2p per week.

Included in next years budget was Decorative lighting for the Esplanade, Buoys for Sandown Bay, Cold Calling Zones and money to cover the maintenance and day to day running of the skate park.

The cost of the Chronicle was raised and the Council was informed that this would be an agenda item for discussion at the March meeting.

Cllr Blezzard proposed an amendment to the budget. He stated the overall cost to the tax payer would not be that great but the overall addition to the precept is almost 10%. He raised the matter of previous meetings two years ago that the post of Clerk be made part time.

He proposed the overall staffing budget be reduced by £14000 and the NI budget be reduced by £1000; the Mayors allowance of £1000 be taken out of the budget and the Councillors expenses of £100 be reduced and the proposed precept be reduced by £15000. This proposal was seconded and a recorded vote was requested.

**Voting against the motion** Cllr Dupre, Cllr Rogers, Cllr Cowley, Cllr Woolley, Cllr Young, Cllr Mereweather, Cllr Teasdale

**RESOLVED:-**

THAT the amendment was lost.

Cllr Young raised the issue of a Youth Council and proposed an amendment that £1000 be used from the reserves for this project but it would stay in the reserves until the Youth Council is functioning and then it is taken out. This amendment was seconded and was put to the vote.

**RESOLVED:-**

THAT £1000 can be used from the reserves for this project but it stays in the reserves until the Youth Council is functioning and then it is taken out.

The budget for 2008/09 as presented by the Clerk was duly proposed and seconded

**RESOLVED:-**

THAT the budget for 2008/09 as presented by the clerk was accepted. That the precept for 2008/09 be £98,000.
